Boys Summer Soccer Nights -7 sessions

Grades 7-12

July 5 – July 26 (Deadline to register Friday June 23*) Mon. & Weds. evenings...6:30pm to 8:30pm
Location: Twin Pines Turf Field Program Fee.....\$175/\$155 HT RES
CHS Coaches Ed Gola and Dan Balog will lead this 7-session program of league play for boys in grades 7-12. The first hour will consist of technical training with a specialized skill training circuit. During the second hour, soccer fundamentals will be reinforced in a recreational but competitive format, in both short-sided and full-sided game situations with qualified officiating and instruction from our camp staff.

Twin Pines Turf Field (July 11 – 27)

These semi-weekly training sessions will help prepare high school and middle school soccer players for the upcoming fall school soccer season. The focus at the sessions will be technical skill development; including passing, receiving, dribbling, and finishing. Speed, agility, and overall fitness will also be emphasized. The core of the daily activities will be small-sided games. The Girls Tech Training Camp sessions will be conducted by HV High School Soccer Coach John McGinley and staff.



Boys & Girls Soccer Conditioning Camp

This preseason conditioning camp for high school girls and boys places an emphasis on fitness, agility, speed, endurance and strength. Conditioning with the soccer ball, as well as small-sided games will be great training for players hoping to compete on the interscholastic level. Camp is conducted by Ed Gola, Dan Balog, John McGinley, and staff.
