







ORDINANCE NO. 2010-2

- 2 -

WHEREAS, in the best interest of the traveling public, motor vehicles with a registered gross vehicle weight in excess of 4 tons shall be restricted on Bear Tavern Road (County Route 579) between I-95 and Washington Crossing Road, Township of Hopewell, County of Mercer; and,

WHEREAS, vehicles in excess of 4 tons are currently prohibited on County Route 579 from County Route 546 to the Mercer - Hunterdon County Corporate Line; and,

WHEREAS, certain conditions on County Route 579 are not conducive for heavy truck traffic; and,

WHEREAS, alternative routes to County Route 579 are available and are more suitable for commercial vehicle through traffic; and,

WHEREAS, the New Jersey Department of Transportation has recommended that a Commercial Motor Vehicle 4 ton Weight Limit be established on County Route 579 between I-95 and County Route 546; and,

WHEREAS, in order to prevent entrapment, the New Jersey Department of Transportation also requires other routes under county and municipal jurisdiction establish a Commercial Motor Vehicle 4 ton Weight Limits established; now, therefore,

ORDINANCE NO. 2010-2

BE IT ORDAINED that, by the Mercer County Board of Chosen Freeholders, that:

1. Commercial Motor Vehicles with a Registered Gross Vehicle Weight in excess of 4 tons are prohibited on County Route 579 between I-95 and the Hunterdon – Mercer County Corporate line.
2. Commercial Motor Vehicles with a Registered Gross Vehicle Weight in excess of 4 tons are prohibited on County Route 637 (Jacobs Creek Road) between NJ Route 29 and County Route 579.
3. Commercial Motor Vehicles with a Registered Gross Vehicle Weight in excess of 4 tons are prohibited on County Route 647 (Nursery Road) between County Route 579 and County Route 611 (Scotch Road).
4. These restrictions shall not apply to Commercial Motor Vehicles making deliveries or providing service to local residents and businesses with no other means of legal access.
5. This Ordinance shall take effect upon approval by the New Jersey Department of Transportation.
6. Regulatory and warning signs shall be erected and maintained to effect the above designated restrictions in accordance with the Manual on Uniform Traffic Control Devices; and,

BE IT FURTHER ORDAINED, that the Clerk to the Board of Chosen Freeholders forward three (3) certified copies of said Ordinance to the Office of the County Engineer for submission to the New Jersey Department of Transportation and distribution upon approval and one (1) certified copy to the Director, Mercer County Department of Transportation and Infrastructure.
