Dear Chairman Bay:

The Delaware Township Committee is in receipt of PennEast's March 14, 2016 letter to you. And again, as stated in the Township's letter dated March 1, 2016, PennEast did not respond correctly to Data Request 38, as it claimed in its December 14, 2015 letter to FERC.

PennEast did not contact the Delaware Township Historic Advisory Committee (DTHAC) in November 2015 or in December 2015. As of the Township's March 1, 2016 letter, PennEast had not contacted the DTHAC. Not until March 15, 2016 did the Historic Advisory Committee receive an initial communication dated March 11, 2016 from PennEast. This communication occurred four (4) months from the date FERC made Data Request 38 and three (3) months later than it claimed to have complied.

The Delaware Township Committee is concerned that PennEast continues to avoid timely and credible responses to the Township's inquiries. The Township also questions the level of detail to which it is being managed in this process by FERC. As stated in the Township's March 1, 2016 letter to FERC, the Delaware Township Committee would like the Federal Energy Regulatory Commission to ensure that PennEast thoroughly completes every request for information by FERC and that it does so in a timely manner.
