RESOLUTION NO. 2015-01


THE DELAWARE TOWNSHIP BOARD OF HEALTH ("Board"), having read testimony from various transcripts and read the Delaware Township Committee's Resolution 2014-59 agree that there may be potential adverse health and safety impacts on the citizens of Delaware Township as a result of construction and operation of the proposed Penn East natural gas pipeline;

THE BOARD HEREBY FINDS that the proposed Penn East natural gas pipeline may pose risks to the health and safety of the citizens of Delaware Township, as a result of, among other things, potential groundwater and surface water contamination, local air quality and odor issues, blasting risk, and risk of physical illness.

THE BOARD will forward this resolution to the Delaware Township Committee for use in any proceedings brought by the New Jersey Department of Environmental Protection, the Federal Energy Regulatory Commission, or other public body considering approval of the pipeline, or for other purposes which the Township Committee deems appropriate.
