The Historic Preservation Commission has noted the following inaccuracies in the URS submission, dated April 26, 2016, regarding cultural resources in Holland Township. Hopefully, these inaccuracies can be corrected. This submission does not constitute consent to or approval of the PennEast project or the process by which PennEast proposes to deal with these cultural resources.

- Page 2, first paragraph, refers to Delaware Township when it obviously should be Holland Township.
- Page 2, second paragraph, parenthetically refers to the Moore Farmstead, which is addressed correctly on page 3. One of the only ways to determine if a Moore once owned this property is through a deed search. However, this paragraph is accurate, so it's probably not that important.
- Page 3, last paragraph, refers to B25 L11.01, which is near Mt. Pleasant. It should probably be B26 L11.01, which is where Gilbert Station is located.
