**A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, IN THE COUNTY OF  
MERCER, STATE OF NEW JERSEY, AUTHORIZING TOWNSHIP OF  
HOPEWELL CHANGE ORDER #2 TO BID # 22-21, 2022 GUIDE RAIL PROGRAM  
THROUGH ROAD SAFETY SYSTEMS LLC**

**WHEREAS**, the Township of Hopewell awarded Bid # 22-21 to Road Safety Systems LLC, through resolution 22-408, on December 5, 2022, in the aggregate amount of \$103,553.50; and

**WHEREAS**, the design engineers Van Cleef Engineering, have concluded unforeseen additional 25 linear feet of guide rail, associated posts and deletes a separate portion of long posts from the original bid; and

**WHEREAS**, the amount of change order is a minor modification and represents a \$894.50 (1.15%) increase in the contract amount, combined with change order #1 (R23-96), in the aggregate is below the 20% cap, giving the new contract amount as follows:

**WHEREAS**, in accordance with N.J.A.C. 5:30-11.3, the change order has not caused the originally awarded contract price to be exceeded by more than 20 percent; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Hopewell, in the County of Mercer, State of New Jersey, that it authorizes a written amendment in the form of Change Order #2 in the amount of an increase of 1.15% (\$894.50) for a total contract price of \$119,457.00 due to the unforeseen required services in

the enactment of bid #22-21 the 2022 Guide Rail Program. This resolution will take effect immediately upon its passage.
