INSTRUCTIONS FOR ZONING PERMIT APPLICATION

- I. All permit applications shall be accompanied by a scaled copy of the property survey showing the location of the proposed building or structure, its dimensions, and setbacks from property lines.
2. Plot plans prepared by a licensed professional (surveyor, engineer, architect, etc.) must include lot coverage calculations.
3. Applications for in-ground pools must provide existing and proposed grading contours at 2-foot intervals.
4. A request for an administrative waiver of a site plan must include the information prescribed by the provisions of § I 7-29.1.
5. All fees must be paid upon application submission. The fees are as follows:

Residential	Fee
New dwelling:	\$75
Addition or alteration of existing dwelling:	\$50
Accessory building or structure: (fence, shed, pool, generator, solar panels, etc.)	\$30
Commercial & Multi-family:	
Administrative waiver of site plan (Note: modifications for individual buildings within the same lot shall be subject to a separate application fee):	\$500
New building, principal structure/use	\$125
Building addition/alteration	\$125
Change of existing use/tenant:	\$100
Accessory structure/use:	\$60
Temporary activity/structure:	\$50
Zoning Certificate	Fee
Zoning certificate/Verification Letter:	\$50
Certification of preexisting non-conforming use or structure:	\$100
Subdivision exemption certificate:	\$100
Stream crossing/lot disturbance:	\$150
Engineering Permit Review	Fee
Residential plot plan and/or as-built survey with site inspection: (new home; in-ground pools; construction of building additions; accessory structures; patios; and similar structures over 200 sq. ft requiring grading changes greater than 2 ft. in elevation)	\$500
Minor stormwater review: (when site plan review is not required)	\$250
Major stormwater review:	\$100 \$750 + \$2 for every sq. ft. of disturbance in excess of 1 acre
Tree removal permit:	\$75 per lot

NOTE: The approval of the Zoning Permit does not relieve the applicant of the responsibility for obtaining any other required local, state, and/or federal approvals, including but not limited to Hopewell Township Construction, Fire, Public Works, and Health Department permits, NJDEP Wetlands or Flood Hazard Area permits, Mercer County and D&R Canal Commission approvals.
